

# Franklin Township Minutes

May 19, 2022 7:05 P.M. Meeting called to order by Gregory Snook  
384 Greenhouse Rd, Middleburg, PA 17842

The Franklin Township Board of Supervisors April meeting was held at the Franklin Township Municipal Building, 384 Greenhouse Road, Middleburg, PA, at 7:00 PM, the meeting was called to order by Chairman, Greg Snook. The following persons present; Supervisors, Greg Snook and Karl T. Zerbe: Kathryn A Shea -Secretary-Treasurer, Karl Zimmerman and Carolyn Zimmerman.

Public comments: Karl Zimmerman spoke about his property in Franklin Township. He presented the supervisors with a letter stating the fact that the Middleburg Municipal Authority has notified the Pennsylvania Secretary of Agriculture that it intends to condemn Bruner Springs Ln and exercise eminent domain. They intend to use Bruner Springs Ln to timber the watershed on the mountain.
